## 2021-22 Registration Information Boys & Girls 2007-2013: B & C Teams

**ISC Gunners Player Registration Fees: \$2,415**

Registration fee Includes:

- Player insurance and US Club registration fees, PSPL Fall league registration fees, NPL league registration fee, ISC Gunners administration costs, full time professional coaching, goalkeeper training, equipment for practices and games, and 2x practices per week during the season.

*\*We are proud to be one of the only clubs in the country to provide a comprehensive benefits package to our staff members.*

Registration fees do not include:

- Players uniforms, tournament fees, supplemental programs (camps, strength and conditioning programs, academies, private lessons, etc).

### **Financial Aid:**

Financial Support is available for qualifying families. To apply for financial aid, you must complete the [Financial Aid registration](#) on our website within 3 days of accepting a spot on a team.

### **Sibling Discount:**

Families with three or more premier players will receive a discount of \$300 off their registration fees. Parents must notify the ISC Gunners finance team ([finance@iscgunners.org](mailto:finance@iscgunners.org)) after they have completed all registrations to receive the \$300 refund.

### **Payment Methods:**

All payments must be made online through Sports Engine. Payments can be made by Credit Card only. We don't accept cash or check. Payment can be made in full when you register, or by payment plan.

If you wish to use the payment plan, the payment schedule is below. Payment plans are charged on the 15th of the month starting in June, and a reminder email will be sent a week before payment is charged. If you decide to pay by payment plan it is your responsibility to keep your payment information up to date so that scheduled payments can be processed.

### **Delinquent Payments:**

If payment plan payments are not made in two consecutive months (two consecutive months of credit card declined through Stack Sports), the player is ineligible to play or practice and player card is pulled until the payment status is made current.

**Payment Options:**

- o **Option 1 (Pay in Full)**- Payment of \$2,415 at time of offer acceptance.
- o **Option 2 (Payment Plan)**- \$1,000 due at the time of offer acceptance. 8 payments of \$181.88 (which includes the \$5 fee per transaction) are due monthly on the 15<sup>th</sup> of the month starting in June and ending in January.

**CLUB REFUND POLICY (Updated Feb 2019)**

**Refunds of registration fees will be issued in accordance with the following policy:**

- **Medical Refund** - Refunds related to significant injury or illness will be granted only with medical documentation from a physician and will be prorated by month based on a 10 month season.
- **Relocation** - If a family is relocating farther than 50 miles during the season, ISC Gunners will provide a prorated refund based on a 10 month season.
- **Other** - Refunds for any other reason may only be granted at the sole discretion of the ISC Gunners Executive Director.
