Re: _____ ISC Gunners WPSL Player Agreement:

Dear _____:

This letter confirms the terms of your player agreement as an ISC Gunners WPSL team member for the 2020 season, (May 4th, 2020 – July 31st, 2020) under the terms and conditions contained in this agreement.

The terms of your role with ISC are as set forth below.

1.) Position.

- a. ISC Gunners WPSL player
- b. You agree to the best of your ability and experience that you will at all times loyally and conscientiously perform all duties and obligations required of and from you, pursuant to the expressed and implicit terms of your agreement.
- c. If you are in a host-housing situation, you agree to spend a significant amount of time with your host family, and you agree to help your host family with anything and everything that is asked of you.

2.) Start Date.

- a. Subject to fulfillment of any conditions imposed in this agreement, this agreement is effective May 4th, 2020.

3.) Compensation.

- a. You will be given absolutely **NO** compensation for your services as a team member/player for the ISC Gunners FC WPSL team. We are an amateur team therefore we do not offer compensation to any player.

4.) Additional Benefits.

- a. **Training Gear.** Each player will receive (2) Nike training tops, (2) Nike training shorts and (2) pairs of Nike training socks to keep hold of for the duration of the WPSL season. You will be required to return both training tops, and both training shorts no later than July 31st, 2020. If you do not return all pieces of the kit, you agree to pay for the missing pieces.
- b. **Uniform.** As an ISC Gunners FC WPSL team member, you will be issued the official uniform for each match; (2) Nike jerseys (one Navy and one White), (2) Nike game shorts (one Navy and one White) and (2) pairs of Nike game socks (one Navy and one White). You will be required to return the uniform following each match to the WPSL Directors.
- c. **Warm Up Jacket.** As an ISC Gunners WPSL team member, you will be issued the official warm up jacket to keep hold of for the duration of the WPSL season; You will be required to return the warmup jacket by July 31st, 2020 to the WPSL Directors.

*** If you are unable to return any pieces of equipment outlined above to be returned, ISC Gunners will invoice you for the missing items and you agree to pay the amount outlined in the invoice by the deadline specified. If you do NOT complete payment, ISC Gunners reserves the right to send the invoice to collections.*

5.) Benefits to ISC: You, as a team member/player for the ISC Gunners WPSL team, will provide the following benefits to ISC at no cost:

- a. **WPSL Golf Tournament.** You agree to volunteer, when and where needed, at the ISC Gunners WPSL Golf Tournament Fundraiser which will be held on Friday, August 21st, 2020 at Mt. Si Golf Course from 7am – 2pm.
- b. **ISC Gunners Tournament.** You agree to volunteer, when and where needed, at the ISC Gunners Summer Challenge Tournament. This includes all field set up, field lining, tournament set up and break down the week before the tournament begins, as well as team check in, BBQ duties, field marshaling, etc. during the tournament days. The tournament will be held June 26th – 28th, and tournament set up and breakdown will be held June 24th – 28th.
- c. **WPSL Soccer Camp.** You agree to volunteer when and where needed, at the ISC Gunners WPSL Soccer Camp (1) for the following dates (SUBJECT TO CHANGE): July 6th, 7th, 8th & 9th, 2020, 8:30am – 12pm.
- d. **WPSL Sister Teams.** There will be several sister team days in which you will be expected to arrive at our practice fields at 4:15pm. Upon arrival, our WPSL Directors will assign you to a particular coach and team for the evening. Sister team days are generally the same days as our WPSL practices, so you will simply arrive early to assist a coach for two practice sessions, then end your evening with a WPSL team training session. The

goal of the sister sessions is to bond with the female youth within our Club; provide them with a positive role model, someone to look up to, etc.

- e. **Game Day Duties.** As a team member/player for the ISC Gunners WPSL team, you will be assigned game day duties that will need to be completed prior to the mandatory arrival time of each match. These duties can include, but are not limited to: field set up, ice chest & water set up, table/merchandise/ticket booth set up, equipment for halftime festivities, raffle ticket equipment and banner hanging.
- f. **Other events.** You may be required to attend other ISC Gunners events throughout the summer. Dates and times TBD.
- g. **Commitment.** As an ISC Gunners WPSL player, you agree to attend any and all events (WPSL games, training sessions, etc..) throughout the season, and update TeamSnap with **ALL** availability.
